A regular meeting of the Freedom of Information Commission was held in the Commission Hearing Room, July 26, 1978. The meeting was convened at 2:10 p.m. The following Commissioners were present:

After consideration of a letter filed by the complainants, the Commissioners unanimously adopted the Hearing Officer's Report.

Docket #FIC78-114 CBS News and Paul L. Loewenwarter vs. State of Connecticut and Commissioner of the State Police Department of the State of Connecticut

Captain Paul Seaman appeared on behalf of the State Police Department. Paul L. Loewenwarter appeared on behalf of CBS News and himself. Attorney Austin McGuigan appeared on behalf of the Chief State's Attorney and, upon his motion to be made a party, the Commissioners unanimously voted to grant him intervenor status in this matter. The parties and the intervenor offered argument on the substance of the decision and the request that the Chief State's Attorney to be made a party to this matter. Attorney Pearlman suggested that the Commission recess in order to draft a consent order in view of the respective positions stated in argument.

The Commission recessed from 5:35 to 5:45 p.m.

The Commissioners unanimously entered the following consent order which was agreed to by the parties and the intervenor, and which was tape-recorded as part of the record in the above-captioned matter:

- 1. The Hearing Officer withdraws her report and the Commission retains jurisdiction over this matter as a contested case.
- 2. The respondent State Police Commissioner shall provide the complainants with access to inspect all materials within his custody or possession which fall within the purview of the complainants' request and which were developed by the State Police Department prior to the convening of the grand jury investigation into the death of Keven Showalter. The respondent Commissioner may withhold from disclosure those portions of such records for which there is a claimed exemption under the Freedom of Information Act, including the names and identities of confidential informants.
- 3. The respondent State Police Commissioner shall also provide the complainants with access to inspect all other materials within his custody or possession which fall within the purview of the complainants' request. The respondent Commissioner may withhold from disclosure those portions of such records which he or the grand juror claim are exempt under the Freedom of Information Act, including the names and identities of confidential informants.
- 4. With respect to each record for which there is a claimed exemption and to which disclosure is withheld pursuant to paragraphs 2 and 3 of this consent order, it shall be the responsibility of the respondent State Police Commissioner, or grand juror, as the case may be, to identify for the complainants such withheld material, without divulging the exempt contents thereof, and to inform them of the specific exemption claimed.
- 5. The complainants may re-open the hearing into this matter with respect to any requested material withheld under the terms of this consent order.
- 6. The respondent State Police Commissioner shall provide the complainants with access to inspect the requested material starting August 1, 1978, with the expectation that such inspection shall be concluded by January 1, 1979.

After adoption of the consent order the Commissioners unanimously granted the Intervenor, Austin McGuigan, the status of party.

Commissioner Lahey left the meeting at 5:55 p.m.

The Commissioners considered a request from Joseph Mannello and Peter Galullo of Waterbury for an advisory opinion. Both Mr. Mannello and Mr. Galullo appeared before the Commission on this request. The remaining Commissioners voted unanimously to deny their request, but agreed to send an official letter from the Commission to the Corporation Cousnel of the City of Waterbury and to the City Clerk of the City of Waterbury on the subject of the Commission's past decisions and advisory opinions on the subject of the minutes of executive sessions.

The remaining Commissioners unanimously voted to table the remaining matters on the agenda, to be considered at the next regular meeting of the Commission.

The Commissioners adjourned the meeting at 6:05 p.m.
