SUBJECT: New and Essential eGrants System Training

The Connecticut State Department of Education (CSDE) is proud to announce the move to an electronic grant application system called eGrants. The goal of this electronic grants system is to reduce the administrative burden placed on Local Education Agencies (LEAs) when applying for grant funding.

The Connecticut eGrants Management System will automate the LEA program submission and review process and allow LEAs to enter budget data and define program-specific activities. Additionally, the system will track the progress of grants through the approval process. The anticipated roll-out of the grants located on the eGrants system is as follows:

The CSDE is offering critical training in the use of this system on September 5, 6 and 7. The half-day (3 hours) training sessions will be held at the Radisson Hotel Cromwell. The CSDE strongly suggests that essential personnel including those who plan, allocate and enter information in grant applications (e.g., assistant superintendents, grant managers, Title I district coordinators, etc.) attend this training. This will be the only training opportunity on how to navigate and utilize the eGrants system. Please share these links with them so they may choose one of the six available sessions to attend.
