The application for reimbursement of 2018-19 Health Services for Children in Nonprofit Private Schools (Form ED017) is now open and may be accessed via the State Department of Education's data collection Web site at <a href="https://www.csde.state.ct.us">https://www.csde.state.ct.us</a>. (Note that a Microsoft Internet Explorer software version 4.01 SP1 or newer is required to properly access the application. Using a software version outside this range may result in report printing issues.) Follow the instructions for the security pop-up windows until reaching the page that lists the various Department data collection options, and click on ED-017 Grant Application for Health Services for Children in Private Schools – Current and Prior Years.

Districts applying for reimbursement must complete all data entry and enter the Superintendent's certification code on or before September 16, 2019.

For those districts that appear not to have nonprofit private schools or did not provide these health services, please refer to Section 10-217a of the Connecticut General Statutes if you have any questions regarding your eligibility.
